# 8\* MOTION (Hon Protus Moindi, Vice Chairman, Committee on Appointment)

That Report on the Committee on Appointment concerning the nominated Chief Officers be adopted by this Assembly.

### 9\* MOTION (Hon Isaiah Mosota, Chairman Rules and Procedures Committee)

Pursuant to provisions of standing order number 234 of County Assembly standing orders the County assembly procedure and rules committee proposes for approval by the county Assembly the following amendments to the County Assembly Standing Orders:

## 10\* MOTION: (Hon. Wilfred Monyenye, Chairperson, Health)

That The Kisii Teaching and Referral Hospital Bill, 2013 be now read a third time.

# 11\* MOTION: (Hon. Samson Matoke Nyagaka, Chairperson, Delegated Legislation)

That the Kisii County Flag, Emblem and Names, 2013 be now read a first time.

# 12\* MOTION: (Hon. Samson Matoke Nyagaka, Chairperson, Delegated Legislation)

That the Kisii Village polytechnics Bill, 2013 be now read a first time.

# 13\* MOTION: (Hon. Charles Onchonga, Chairperson, Agriculture)

That the Kisii County Disease Control Bill, 2013 be now read a first time.

# 14\*MOTION: (Hon. Charles Onchonga, Chairperson, Agriculture)

That the Kisii County Plant Health Bill, 2013 be now read a first time.

### 15\* MOTION (Hon. Phelister Ochako Metobo)

Aware that article one of the constitution reaffirms the sovereignty of the people of Kenya, Mr Speaker; women form the majority of Kenyans. Therefore, I move the following motion that seeks to form the committee on Gender to cater for special interests of women in order to meet the constitutional threshold in liaison committee.

Further aware that chapter four; Bill of rights (that is firmly based on the principles of the universal declaration of human rights (UDCHR) include equality, non-discrimination equity and human dignity, article 21(3) obligates the Assembly to address the needs of the vulnerable groups.

I move the motion for the creation of the committee on Gender, Youth and Disabled.

# 16\* MOTION (Hon. Protus Moindi, Leader of Majority Party)

Aware that service delivery depends on revenue collection, and that the government stands to lose **Kshs.166**, 357,483/= in non- payment of property rates by property owners, further aware that the government targets to raise 1.1b in revenue collection for the financial year 2013/14, this house approves the government's request to introduce and extend a waiver of interest on all rates defaulters for a period of one month to motivate them to pay the principal.

#### 17\* MOTION ~ (Hon. Samuel A. Onukoh)

Aware that livestock trading is a major revenue earner to this County and that the livestock traders make their income from the buying and selling of livestock; I this house urges the ECM in charge of Agriculture sector to give a comprehensive report as to why a quarantine imposed in December 2013 has not been lifted. I urge this house to pass a motion that this quarantine be lifted within one week.

#### 18\*MOTION ~ (Hon. Obote Motonu)

Under standing order No 73 (1) English, Kiswahili sign language.

Aware that Kisii County has residents who are impared (disabled) as other counties in the republic of Kenya, Further aware that the Kisii County Assembly is the replica of the National Assembly, Further aware that the National Assembly has put in place sign language people to translate the proceedings in the honourable house, we ask the Kisii County Assembly to put in place people of sign language to translate the proceedings in this honourable house.

#### 19\* MOTION ~ (Hon. Ronald Onduso)

THAT aware that Article 69 (a) of the Constitution of Kenya provides for sustainable exploitation, utilization, management and conservation of the environment and natural resources, and further aware that Environmental

Management and Co-ordination Act of 1999 provides for a right to a clean and healthy environment, however, our environment has been depleted and over-exploited due to excessive planting of eucalyptus trees along our river banks and water reserves, and careless burning of industrial waste materials resulting to depletion of the ozone layer, drying of rivers and diseases to our populace. I therefore urge this honourable house to compel the executive of Kisii County Government to put measures and ensure conservation, management and utilization of our environment for the benefit of the people of Kisii County.

#### 20\* MOTION ~ (Hon. Ronald Onduso)

THAT aware that Kenya is an agricultural country and most of our economy is dependent on agriculture, and that our farmers in Kisii County are dependent on agriculture for a living, and further that however, hard our farmers are working, most of them are not benefiting from their efforts because of exploitation from scrupulous middlemen rendering our farmers poor and helpless, there is need to cushion our farmers from such exploitation and poor pricing. It's for this reason that I urge this honourable house to compel Kisii County Government to establish a regulatory body for sugarcane and other produce in Kisii County.
