**APPROVAL OF NOMINEE TO THE POSITION OF THE SECRETARY
TO THE KISII COUNTY PUBLIC SERVICE BOARD**

(The leader majority Hon. Protus Moindi)

THAT, this House adopts the Report of the appointment committee on the Vetting of nominee for the position of the secretary to the Kisii County Public Service Board laid on the Table of the House today, Tuesday, September 16, 2014 **approves** the appointment of **Mr. Charles Bosire Nyakeiya** as the secretary to the Kisii County Public Service Board

9*. MOTION (HON. RONALD ONDUSO) *Resumption of Debate on 13th*

August 2014

THAT, aware that Kisii town is fast growing and getting overpopulated, there is need to have an efficient transport system; deeply concerned that the CBD is congested with motor cycles and heavy commercial vehicle, this County Assembly resolve that the Transport System be regulated so that motor cycles and matatus as well as heavy commercial vehicles can operate from designated areas and more particularly that motor cycles do not access the CBD. And that all efforts necessary are made to decongest pavements, parking lots/bays, back alleys and street

10*.MOTION (HON. ISAIAH MOSOTA)

THAT, aware that the water is a basic need and that the county cannot exclusively depend on primary sources of water to satisfy all its water needs; deeply concerned that the sole dependence on derivative water sources leads to interruption of water related activities due to insufficiency; recognizing that water harvesting is a crucial secondary source of water; noting that a lot of water has dissipated due to ineffective programmes and initiatives for harvesting water; cognizant of the fact that rain water that is not harvested causes environmental degradation and damage to infrastructural facilities; recognizing that Article 69 (2) of the constitution confers to every person a duty to cooperate with state organs and other persons to protect and conserve the environment and ensure ecologically sustainable development and use of natural resources; This Honourable House resolves that the County Government to initiate and formulate water harvesting policies to guide water harvesting programmes in all the 45 wards to reduce over dependence on primary water sources.

11* MOTION (HON. ISAIAH NYAMWEYA MOSOTA)

THAT, aware that the level of unemployment among youths in Kisii is over 70% and rising; concerned that the formal Sector is unable to generate sufficient formal employment for college graduates, resulting in far reaching ramifications to the

economy and society across all wards in Kisii County; noting that the youths are unable to venture into private enterprises because of lack of access to affordable credit; the Assembly urges the County Government to take urgent and immediate steps to ensure legislation is enacted to provide for the establishment of a Graduates Enterprise Fund to offer revolving interest-free loans to unemployed graduates in all the 45 wards.

12* MOTION (HON. ISAIAH NYAMWEYA MOSOTA)

THAT, aware that Kisii County benefits immensely from the Kenya and local sweet bananas market; cognizant that sweet bananas are an important component for better health; noting that sweet banana production is perennial in nature and that sweet bananas are highly vulnerable to diseases such as banana wilt and are further prone to high rate of perish ability leading to massive wastage and losses of sweet bananas and their stalk ; concerned that the County government has not come up with adequate measures of curbing the losses as a means of protecting sweet bananas growers; further concerned that Kisii County residents grow sweet bananas as one of the mainstay crops for sale and consumption; This Honourable House urges the county government to develop a policy on sweet banana preservation and storage through modern refrigeration and also to provide measures to control and mitigate losses occasioned by banana wilt and other diseases.

13* MOTION (HON. ISAIAH NYAMWEYA MOSOTA)

THAT, aware that towns and urban market areas in Kisii County are increasingly getting overpopulated leading to overstretching of services and amenities; concerned that improper management of waste has become a major cause of pollution of neighborhoods, water sources and other natural resources leading to rise of environment-related diseases which cause many deaths; further concerned that in most urban areas, waste is dumped in an uncontrolled manner posing a great

challenge to the wellbeing of urban dwellers, particularly those living near dumpsites; acknowledging that the problem continues to rise despite the efforts made to mitigate the problem through various statutory bodies, private entities and communities; the Assembly calls upon the County Government to take immediate steps to develop effective waste management regulations and put in place proper disposal facilities, including for harmful waste and that this be done in consultation with all key stakeholders.

14* MOTION (HON. ISAIAH NYAMWEYA MOSOTA)

THAT, noting that the Constitution of Kenya, 2010 fundamentally changed the architecture of Government in the country; aware that many people in Kisii County including elected leaders are not conversant with the new structure and especially the devolved system, the Assembly urges the County Executive to undertake comprehensive, well-structured and systematic civic education countywide on the new system so that the Kisii people can understand and positively participate in its implementation.

15 *.MOTION (HON. ELKANA NYANDORO)

THAT, aware that the County Government of Kisii through the County Public Service Board has made several Appointments in a bid to operationalize the institution of the County Government, and aware that the Constitution of Kenya 2010 has set strict thresholds. This County Assembly requires the Board to furnish the data of Appointments since the inception of the County Government to date
