The County Government of Kisii has noted with concern that developers are undertaking constructions of buildings, erecting of perimeter walls and subdivision of land and major renovations within Kisii County without following the proper development approval process and attaining approvals from the County Government thus risking the lives of the occupiers and citizens at large.

Pursuant to Schedule Four of the Constitution and Sections 56, 57,58,59 and 60 of the Physical and Land Use Planning Act No. 13 of 2019, the County

Government of Kisli wishes to notify developers, investors and the general public to ensure the following while undertaking developments:

1. To obtain development permits from the County Government for all forms of developments. The permits to be obtained include but are not limited to; the Construction Permits for all developments e.g., buildings, walls and other civil works by developers, investors, companies, learning institutions, religious organizations, hospitals and other healthcare organisations, Non-Governmental Organisations, National and County Government Ministries, Departments/Agencies, or by any other persons undertaking developments.

To obtain these development permits from the County Government, an application should be done to the County Executive Committee Member (CECM) in charge of Lands Physical Planning and Urban Development. This is done through filling an application form available at www.kisii.go.ke, the municipal office and all sub-county offices and attach the following:

i. Five copies of the architectural plan done by a qualified and registered architect

ii. Five copies of the structural plan done by a qualified and registered structural engineer.

iii. A copy of the title deed and a recent copy of the search

- A copy of the lease Receipts of payment to revenue National Environmental Management Authority (NEMA) certificate National Construction Authority (NCA) Certificate

- Obtain Certificate of Completion and Certificate of Occupancy when development has been completed and before the building is occupied.
 Before obtaining the certificate of completion and occupancy; the developer is required to provide proof that:

 the construction plan was approved and supervised by the County Government/Local Authority (defunct)
 the construction was done by licensed contractors and supervised by licensed engineers and other professionals.
 the architectural and structural drawings were designed and approved by licensed architects and structural engineers and confirmed by the County Government during approval of Development Permit.
